Overview

The Nelson County Comprehensive Plan will be based on research, data analysis, and, most importantly, community input. Throughout the process, this Comprehensive Plan update will take deliberate and extensive steps to ensure that all community members have an opportunity to help shape the visions and goals of the community. This report summarizes the following community engagement activities conducted as part of the public engagement phase of the process (July 1 through August 31, 2022):

- Idea wall: The Nelson County Comprehensive Plan website included a page for the community to leave comments and ideas for the Comprehensive Plan Update.
- **Community Workshops:** During four community workshops, community members were introduced the Comprehensive Plan process and invited to work together in small groups to complete exercises on Countywide and topic-focused issues.
- **Stakeholder Listening Sessions:** County organization and business representatives participated in four discussion based listening sessions. Each session focused on a separate theme relevant to the Comprehensive Plan update process.
- **Public Survey:** A survey consisting of 23 questions, tailored to identify strengths, weaknesses, and future needs of the community, was made available for community members to take online through the Comprehensive Plan website or physically on paper copies distributed throughout the County.





Big Ideas

Throughout the public engagement process, four key themes, or "Big Ideas", were identified across all of the community engagement activities. These Big Ideas will frame and inform the strategies and goals created for the Plan and are as follows:

- 1. Plan & Provide Equitably for Everyone
- 2. Diversify & Bolster the Local Economy
- 3. Improve & Expand Vital Community Services
- 4. Protect & Connect to Natural Resources

Additional details on these big ideas will be shared.





Outreach and Publicity

During the public engagement process, the following outreach and advertising mechanisms were used to get word out about the plan update and opportunities to participate.

o The Nelson County website also contains information regarding the plan process and will be used to post official meeting minutes from joint worksessions between the Planning Commission and Board of Supervisors.

Idea Wall Results

In July of 2022, Nelson County launched the official website for the Comprehensive Plan update process known as Nelson 2042. This website contained links to public engagement opportunities and useful resources, news posts and pertinent information, as well as an idea wall where community members were encouraged to post a comment to let the County know what they were thinking about the update process and what they hoped to see in the future.

So far, 35 comments have been posted to the idea wall. Comments on the wall have ranged in topic with the most prevalent themes of comments pertaining to the protection of natural environment, traffic improvements, and pedestrian and bicycle infrastructure improvements.

Examples of comments included on the idea wall:

- "Please keep supporting our natural world! Support a sustainable ecosystem. Ensure we have a healthy world for our children, grandchildren & beyond!"
- "Resolving dangerous sections of 151 should be a priority before the County entertains any further development that will increase traffic."
- "If there was a safe and visible path for bikes and pedestrians to use along the 151 corridor, it would alleviate conflicts with vehicles, and perhaps even reduce the number of sight-seeing vehicles on the road."

The Nelson 2042 website will continue to run throughout the entirety of the Comprehensive Plan update. Comments added to the idea wall will continue to be tracked and considered throughout the update process.



Community Workshops

Nelson County conducted four community workshops to gather input from the community for the Comprehensive Plan update. These workshops were conducted in Summer 2022 on July 13th, July 20th, August 3rd, and August 28th.In total, approximately 150 community members attended the community workshops over the four sessions.

The workshops began with an introductory presentation that briefly explained the comprehensive planning process and detailed the importance of public input. Following the presentation, attendees split into groups to work on breakout discussion exercises.

Each group discussed and documented Countywide strengths, weaknesses, and opportunities – as well as goals for the future. Additionally, each group focused on a key planning element: Growth & Development, Transportation & Infrastructure, and Parks & Recreation. A tabulated summary of the responses collected from all of the public workshops can be found in Appendix B.

July 13, Nelson County High School. (35+ attendees) The top strengths identified at this workshop were the County's natural beauty and resources, its sense of community, and its central location and proximity to urban centers. The top weaknesses identified were the lack of infrastructure (such as water, sewer, electric vehicle charging, or broadband access), housing challenges (including those related to affordable housing), and a lack of public recreation areas (such as parks and playgrounds). The top goals and improvements for the County included preserving natural spaces and rural lands from development, attracting industries to expand the County workforce, and implementing reliable public transportation options.

July 20, Rockfish Valley Elementary School. (40+ attendees) The top strengths identified at this workshop were the County's rural and agricultural character, natural beauty, and sense of community. Its top weaknesses were identified as housing challenges (including a lack of affordable housing), traffic issues (including congestion along the Route 151 corridor), and not enough infrastructure (such as water, sewer, and broadband access). The top goals and improvements identified for the County were actions to bring in more affordable housing, expanding the workforce by allowing more tax-generating businesses, and improving traffic patterns and adding additional turn lanes for safety and to ease congestion, specifically along the Route 151.



August 3, The Nelson Heritage Center. (40+ attendees) The top strengths identified at this workshop were the County's natural beauty and resources, its welcoming and family-oriented community, and its mix of riparian, agricultural, and mountainous areas. The top weaknesses identified were the limited career opportunities and few economic drivers, the lack of public recreation resources (such as parks and playgrounds), and transportation infrastructure and issues (such as public transportation and traffic safety). The top goals and improvements for the County were identified as building more indoor and outdoor recreational facilities, increasing the employment base by attracting more economic growth, and creating more affordable housing.

August 28, The Nelson Center. (25+ attendees) The top strengths identified at this workshop were the County's natural beauty and resources, its sense of community, and the clean air and water quality. The top weaknesses identified were the County's limited access to health care options and mental health services, its lack of affordable housing, and the insufficient fire and rescue services. The top goals and improvements identified at this workshop were increasing the housing stock for low- and medium-income residents, increasing recreational opportunities, and expanding economic growth and opportunities.





Word Cloud

Attendees at each public workshop were given the opportunity to submit a single word that they would use to best describe Nelson County. Over the course of all four workshops, 85 responses for this exercise were received. These responses were put into a word cloud, which can be found below, to help visualize what community members think of when they think of Nelson County. This word cloud increases the size of the word submitted based on how many responses of that word were included.





Stakeholder Listening Sessions

Four stakeholder listening sessions were held throughout the community engagement process. One was held on July 13th, another on July 20th, and two on August 3rd. Facilitated by the Berkley Group, attendees were selected for their direct involvement in each given topic and included representatives from local businesses, community organizations, realtors, developers, healthcare, and agriculture, among others.

These facilitated discussions gave participants an opportunity to discuss key issues and opportunities in the community that related directly to their areas of interest. The four meetings focused on different topics: housing & development, lodging & tourism, agriculture and agritourism industries, and community groups & nonprofits. Listed below are some of the most common themes that were discussed during these meetings, though many other topics were raised. A full summary of the discussions held at each meeting can be found in Appendix C.

- Nelson County has a limited housing stock which is affecting many aspects
 of the community in unforeseen ways. Notably, many employers are having
 difficulty finding employees and many current employees have to
 commute into Nelson County from places like Waynesboro or Amherst
 because there are limited rental or affordable housing options. Much of this
 rental housing stock has been repurposed for short-term rental options
 catered to tourism.
- There are few career-oriented economic opportunities for residents and, subsequently, there are less young families and young professionals staying in Nelson County. Many of the residents in the County instead commute to urban areas such as Charlottesville, Staunton, Waynesboro, or Lynchburg.
- The lack of available infrastructure, specifically public water and wastewater is having a detrimental effect on the necessary development in the County, which includes additional housing, lodging, and economic opportunities. Additional infrastructure should be targeted along the Route 29 corridor where it can be supported.
- Nelson County's rural and agricultural character, as well as its accompanying natural beauty, are its greatest asset. This character should be preserved as much as possible, and future development should be done with preservation in mind.



- While historically Nelson County's economy has been driven by agriculture and raw material processing, it has shifted recently to one centered more around tourism. Preserving Nelson County's agricultural heritage will require a multifaceted strategy to include farmer education and recruitment programs, continuation of land use taxation, and reducing barriers to activities that support viable agricultural businesses (e.g., agritourism, support businesses).
- With most retail, lodging, and other tourism related businesses being centrally located along the Route 151 corridor, overdevelopment concerns have been raised, such as an abundance of traffic and loss of natural habitats. Development should be focused elsewhere in the County, specifically the redevelopment and rehabilitation of historically populated areas, such as Lovingston.
- Healthcare, fire, and emergency services have been identified as lacking for community members of all ages. Additional emergency services are required to help cut down on long response times that could have lifethreatening consequences. Additional care for the aging and elderly could help improve their quality of life, especially with those who have difficulty traveling to distant urban centers.
- An increase in available public transportation can help improve the quality of life of community members of all different demographics, such as offering additional transportation options for tourism and recreation, the elderly and aging, and those without access to private transportation options. While some community organizations currently help fill this gap, additional support from the County is desired to increase the amount of public transportation options and better serve community members.
- Additional recreational opportunities for community members can help improve quality of life and help make Nelson a more attractive and livable place. Some recreation services are currently being fulfilled by community organizations but further expansion of these services and a centrallylocated, County-funded, recreation center have been identified as desirable options by community members.



Public Survey

During the community engagement process, a public survey was made available to collect input from the broader community. The survey included 24 questions designed to provide an understanding of the top concerns and goals of the community. Of these 24 questions, 14 were directly related to the Comprehensive Plan, 9 were about respondent demographics, and 1 was for contact information. The survey was available online and in hard copy from July 1 to August 31, 2022. During that time, 885 community members took the survey, with 811 taking it virtually online and 74 submitting a paper copy response. The results of this survey are summarized below and are vital to the Comprehensive Plan update. For the full survey results, please see Appendix D.

Top 3 focus areas for Nelson County's future:

- Preserving environmental resources 55.4%
- o Improving public schools 29.6%
- o Promoting affordable/quality housing 27.5%

General quality of life:

 61.4% of respondents do not believe there is enough affordable housing.

- 57.4% of respondents do not believe there is enough variety in housing.
- 55.1% of respondents are not satisfied with shopping opportunities.
- o 91.1% of respondents feel safe in Nelson County.
- 47.9% of respondents do not feel there is enough public transportation.

- 42.3% of respondents do not believe that Nelson County does enough to support agriculture and preserve rural environs.

- Top 3 least desired land uses in Nelson County:
 - o Industrial development 62.4%

 - Telework/work from home 66%
 - Medical services 58.7%
 - Agriculture and forestry 52.6%

 - Affordable housing 52.9%
- Top 3 locations for new residential development:
 - o Central area (Lovingston, Colleen, Shipman, etc.) 49.9%

- Top 3 locations for new commercial development:
 - o Along Route 29 56.8%
 - Central area 43.8%
 - Redevelop existing sites/buildings 43.1%

 - o Bicycle/trail connectivity (signage, bike lanes and paths) 49.5%
 - Public transportation 40.2%
 - Traffic and road safety 38.5%
- Top 3 most desired recreation facilities:
 - Trails for biking, walking, or hiking 60.9%
 - o Indoor/outdoor pool 36.7%
 - Small-scale parks with open spaces 35.4%
- Top 3 priorities for improving public facilities and services:
 - Fire and rescue/ambulance services
 - Public schools
 - Medical/clinical services



Demographic Questions:

- **Place of residence:** The majority of respondents were from the Nellysford or Afton/Rockfish areas.
- **Place of work:** Most respondents were retired with many working in Nelson County or telework/working from home.
- A large majority of respondents were permanent residents of Nelson County or owned property in the County.
- Age: The top 3 age brackets for respondents were: 65 or older, 55-64, 45-54.
- Race: A large majority of respondents were white.
- **Tenure:** Of the respondents that identified as residents of Nelson County, there was a slight majority that have lived in the County for 40 or more years with the second largest group having lived in the County for less than 5 years.
- **Internet**: A large majority of respondents have sufficient internet service at their place of residence.
- **Cellular wireless service:** The majority of respondents believe cell phone service is sufficient at their place of residence with approximately a quarter of respondents having insufficient service.

Date	Subject	Comment
2-Sep		I hope Nelson County will take measures to ensure we do not become inundated with light pollution. The dark skies of Nelson are beautiful, and business/residential development must be managed to keep it that way. I am not anti-development in any way - I am just saying that as the country grows, we need to protect our skies and dark mountain views from light pollution.
29-Aug	Climate Disruption & Potential Increased Demand for Land Clearing	VA has 10,000 miles of tidal shoreline, making our shoreline the longest of any state in the continental U.S. We have more shoreline than Florida! 78% of Virginians live within 20 miles of the Chesapeake Bay, the Atlantic, and tidal rivers. Second only fo New Orleans, Hampton Roads is the largest population area in the U.S. with the highest risk from sea level rise. A report prepared for the VA legislature by the VA Institute of Marine Science predicts a sea level rise in Hampton Roads between a minimum of 1 foot to a maximum of 2.2 feet by 2050. (See Norfolk, Virginia Virginia Institute of Marine Science (vims.edu) But sea level rise does not stop in 2050. Worst-case scenario predicts a potential 7.5 ft sea level rise on the coast by 2100. What happens when people begin moving inland from the VA coastline? Along with other counties, Nelson could experience unprecedented growth pressure from citizens wanting to move here to buy and build houses on high ground. We need to be prepared for this possible eventuality if we are to preserve the things we hold dear today – clean air, clean water, night skies in which we can see the stars, a rich biodiversity of plants and animals, forested mountains, open farmland, low crime rate, and a community spirit that far exceeds that of many places. Indeed, since scientists know that trees are the best carbon capture technology in the world, our forested landscape can only become more valuable in the future. Intelligent zoning can prevent rampant development from destroying our natural heritage. Our Comp Plan must identify areas where clustered development is appropriate, and just as important, where development is NOT appropriate. The mission statement of the Board of Supervisors begins with, "It is the mission of the Board of Supervisors to maintain Nelson County as a beautiful, safe, healthy, and prosperous rural county; where public services are effective, efficient, adequate and responsive to the needs of its citizens." We must ensure that our new Comp Plan includes plan
29-Aug		Please set up FedEx / UPS drop box locations at the courthouse. Residents and small business owners are disadvantaged by needing to leave the county to access drop box locations for FedEx and UPS.
29-Aug		Extend the Blue Ridge Railway Trail all the way down the Tye River to Norwood and allow for pedestrian access to the James River State Park.
29-Aug		Plan for a ferry, footbridge or some other form of pedestrian crossing of the James River in Norwood so people can access the James River State Park without driving.
29-Aug	IKAIIWAV ITAII	Make plans to add a Public access point to the Blue Ridge Railway Trail where it ends near Rt 29 in Tye River / Arrington

Date	Subject	Comment
27-Aug	Open Space	The American Farmland Trust recently released a nation-wide study in an effort to predict the future of farmland. See: Farms Under Threat - Future Scenarios (farmland.org) Interactive maps allow users to zoom down to the county level to see predictions of the loss of farmland to development according to a variety of scenarios. The scenarios range from "business as usual" to run-away development. Technical assistance for the maps was provided by USDA's Natural Resources Conservation Service and two other partners. Using the "business as usual" scenario, 2,800 acres of farmland could be lost to development by 2040 in Nelson County without zoning to protect high quality farm areas. The Trust for Public Land (www.tpl.org) compiled a report on VA that compared land use to the tax base. The report found that land used for farming and forests and land under open space and conservation easements requires on average \$0.35 in services for every \$1 paid in taxes. By contrast, residential lands require an average of \$1.18 in services for every \$1 paid in taxes. Open space therefore subsidizes the cost of residential services in a county. Profits from housing construction are private, but costs in terms of expenditures on services are public – we all pay.
9-Aug	Keep Nelson Natural	One of the reasons I love NC is the amazing natural world around us: Rivers, Creeks, Mountains, Forests, Wildflower & native grass meadows, farm fields, bear, bobcats, deer, opossum, birds, butterflies, bees. It's all available whether hiking, canoeing, fishing, hunting, gardening, or working the fields. We're so fortunate! Our trails (Piney River Railway, Rockfish Valley, Appalachian Trail, Fortune's Cove, Wintergreen & more). Please keep supporting our natural world! Support a sustainable ecosystem. Ensure we have a healthy world for our children, grandchildren & beyond!
6-Aug	How do we pay for this?	Lots of great ideas here, and presented at the 3 Comprehensive Plan workshops. One challenge is for the County plan to establish objective milestones, and managing and reporting progress against those milestones. The bigger challenge is how the County can fund this wish list. Raise taxes on short term rentals for one. A surcharge on speeding tickets, but enforcement is already pretty light. Tourists are captive audiences once they are here, can we bump up the tax on alcohol served at local breweries and wineries? In general, future development should come at a price. What else? What are other similarly situated counties doing?
3-Aug	Transportation, Schools, Development	Important needs to include in the plan: 1. Transportation options – for older folks and those without cars who live out in the county – to get groceries and medications locally, and for medical needs in C'ville or L'burg. Perhaps this would mean greater financial support for JAUNT so there are more frequent options, especially with the growing number of seniors in the county. 2. Increased support for education. Nelson county's children are our future. 3. Development needs to be in keeping with our rural character. Commerce and small-scale industry should be focused along Route 29.
2-Aug	More is not better	I am happy to share the beauty of Nelson with tourists, and have no problem with residents offering Airbnb services. But outside investors erode the very feeling of community that makes it attractive to residents and visitors alike. Restrict short-term rental investment properties to specific zones; add drunk driving check points along the 151 corridor; fund affordable housing / long-term rentals; improve youth and elder services (how about a pool?) especially in the south of the county; recycle glass.

Date	Subject	Comment
26-Jul	Short Term Rentals	We came to the mountains to get closer to nature, to homestead and live a quiet, wholesome life. Our little hamlet of 6 houses where all the neighbors knew each other, helped each other out, shared any issues and worked them out, has changed since 2 houses were bought by groups of investors living in DC running them as AirBnBs. It feels like a hotel has been built in our residential area that doesn't have a front desk manager and now my neighbors and I have to police the darn houses! There has already been dogs off leashes (two of our homesteads have free ranging chickens), drunken men walking onto properties with children, loud music late at night and light pollution all night long. I am not against short term rentals, but having the owners treat it as a business investment with no ability to be present to respond immediately to problems, makes it a commercial property. We should be zoning this more carefully. Nelson County should only allow full-time Nelson County residents own and run their own rentals. That makes more financial sense to me and keeps our neighborhoods in tact. Keep businesses local!
25-Jul	Older adults	Nelson has one of the largest populations of older adults in our region. It is important we invest in the services needed to help older adults age in the community.
20-Jul	My Thoughts	I cherish the rural nature of Nelson County. Dark skies are nice. The world has plenty of developed areas with gross amounts of light pollution. I suggest that Nelson County maintain its rural character. This should become increasingly desirable as time passes. We have enough wineries, breweries, cider houses. Let's sit back, breathe deeply and enjoy our natural environment.
20-Jul	Route 151- safety and tourism	Route 151, primarily between the Albemarle County line and Devils Backbone/Wintergreen, sees a lot of tourism traffic all year, but especially in the warm months when folks want to hike and bike and eat/drink outside. For those of us who live off Route 151, the traffic and "leaf-lookers" can be annoying, but the real safety hazard is the lack of bicycle and pedestrian infrastructure along this corridor. If there was a safe and visible path for bikes and pedestrians to use along the 151 corridor, it would alleviate conflicts with vehicles, and perhaps even reduce the number of sight-seeing vehicles on the road. Perhaps folks would park at RVCC or Nellysford and use the bike path to visit local attractions. In addition to providing a safer corridor with less conflict, an off-road path would allow local residents to safely walk and bike to shops, schools, nearby neighborhoods, and jobs. Many rural and semi-rural communities have integrated bike and pedestrian pathways into their community with great success.
19-Jul	Short term rentals	There are areas where short term rentals may work better than others. The overall tone of county residents I have spoken with seems to be, restrictions of short term rentals in established neighborhoods of predominantly single family homes will benefit cohesiveness and a sense of community. Hopefully residents of Nelson County want to preserve this sense of community rather than become so urban that one barely knows their neighbors, a likely prospect if short term rentals are allowed anywhere. Nelson county also has been added to a list of counties vying for tourism grant money which can be used for the creation of short term rentals and hotels. Yikes!

Date	Subject	Comment
19-Jul	Don't kill the goose that laid the golden egg!	Echoing some other posts, I would strongly urge the county to preserve that which makes it a desirable place, that which draws the visitors here - its natural beauty. I have already seen some thoughtless development - like the ugly huge houses going up in what used to be one of the prettiest fields along Route 151, at Chapel Hollow Road. Development for development's sake (\$\$\$) is short-sighted, with long term damage to the natural landscape. Don't turn Nelson County into another suburban sprawl disaster. Perhaps concentrate thoughtful, careful development in a few selected areas; other states have done this. Definitely talk to other localities that are struggling with, or have successfully managed, careful growth with the natural environment.
	Invite Highland County to share their experience	Highland County has been thinking through many similar issues for a long time: maintaining environmental integrity, encouraging thoughtful job growth, nourishing community spirit, supporting sustainable tourism. Let's host an exchange and learn from and with officials and residents in other counties in Virginia on how they've been thinking about and tackling these issues.
18-Jul	Environment and community are our assets	People around the world are realizing that the natural world is invaluable - our forests, water and air are our most precious gifts. Nelson has these in spades, and we've valued and fought for them for a long time. Protecting our natural world must be at the center of our plan for the future, as this will only become more important. This means ensuring the cleanliness of our streams and rivers to protect our drinking water and provide recreation opportunities, keeping our forests intact and standing with good hiking trails, and ensuring our air remains fresh and healthy. We could encourage environmental art installations, sustainable foraging activities, seed saving programs and dark skies opportunities. And we can't do it without our sense of community: One thing that makes Nelson special is our care for community coming together with all our diverse backgrounds, languages and perspectives makes us vibrant and rich. Cultivating opportunities for us to come together as a diverse community for our human and natural world will keep Nelson strong and thriving well into the future.
18-Jul	Safety Route 151 and AirBnb Rental Concerns Restrictions	Would like VDOT and the County Board to resolve blind curves and other problem areas along Route 151 before approving new projects. Another new project was recently approved, but road issues remain. Example: Blind curve at Spruce Creek Ln Route 151. A hazard for residents, Emergency Response Units, and school bus drivers. Also, would like to see guidelines and restrictions setup for AirBnb VRBO rentals. They're are being allowed to setup close to residential homes and subdivisions. Problems arise and concerns from residents. Albemarle Country has guidelines restrictions in place. Thank you.
13-Jul	Recycling and Recharging	It would be nice if Nelson County accepted glass at the recycling center, as Augusta and Albemarle do. Also, it would be very good if Nelson County had some electric vehicle charging stations.
12-Jul	Streetscapes	Go after grant money to create a real streetscape in Nellysford and Lovingston - the 2 main business areas. 

Nelson County Comprehensive Plan Update Stakeholder Group #1 (Housing & Development), Notes



On July 13, 2022, the Berkley Group facilitated a stakeholder listening session on housing and development. This meeting was held at the Nelson County High School in a roundtable discussion format. Eight stakeholder attendees were present, representing organizations and businesses, such as Saunders Survey Inc., Keller William Realty, and Wintergreen Property Owners Association. Stakeholders were asked what issues and challenges their organizations and businesses see in the County with a specific focus on housing and development. The following is a summary of the subsequent discussion.

Affordable Housing

- There is a significant lack of affordable housing in the County. Students that graduate
 from Nelson High School are having a difficult time, and usually aren't staying in Nelson
 County because there are not enough affordable places to live and not enough jobs
 to keep them here.
- Plenty of people live here and commute to areas like Charlottesville, Waynesboro, and Lynchburg for work. This is due to the lack of economic opportunities in the County and employment in the County not being able to cover the cost of living.
- It is difficult to get residents to accept affordable housing projects due to stigma surrounding the term "affordable housing." Many people see it as undesirable and low-quality housing. A broad spectrum of quality housing, including subsidized housing, is needed. Affordable housing is needed for middle class families.
- The availability of housing has fallen because so much of it has been bought up. This
 was attributed to the County's relaxed standards on short-term rentals, the availability
 of broadband, low interest rates for mortgages, and the general beauty and natural
 recreation that makes the County desirable.
- The Western portion of the County is very expensive and probably will not ever be affordable to live in again.

Employment

- Tourism has a real opportunity to support residents in the County with jobs, but it is not currently enough to sustain the whole County. Employment opportunities such as agriculture, nurseries, and cold storage would be welcome and appropriate.
- Family farms are disappearing, and agriculture is not as large of an economic driver as it once was in the County.
- Attracting major industries can only happen when the County has the capacity for employees in terms of housing and activities.

Water & Wastewater

- Water and sewer availability has been a major barrier to housing development in the County because it is very expensive (due to physiographic constraints) to expand public services and to install private wells and drain fields.
- The current sewer system was not well thought out and needs to be expanded/connected wherever possible.
- There is no water and sewer master plan. Developing one should be a major priority.
- There are not enough restrictions placed upon development adjoining riparian borders in the County.
- The County needs to be more conscientious about using up the groundwater and water supply.
- There are a lot of old wells in the County. Water testing needs to be made readily available and advertised to citizens.
- Arrington does not have a lot of water. Development in the Piney River area is also not likely to happen due to a lack of water or sewer. Colleen has potential to develop if improvements to water and sewer are made.

<u>Tourism</u>

- Participants stated that a lot of the County's housing stock has been purchased for use as short-term rental housing. Many of these houses would have otherwise been used for the long-term rental market.
- Most people that take advantage of the recreational assets in the County are tourists or people from outside Nelson County.
- Tourism is currently the only major draw of the County for new residents and visitors.

Amenities

There are not enough recreational facilities for families and children, such as sports fields.

<u>Development</u>

- The Lovingston area is a great place of opportunity for development of housing, retail, and services.
- There needs to be more investment into the development of the downtown Lovingston area. That development needs to take place on the Lovingston side of Route 29, not on the side where Food Lion is located. Connecting these two areas should be prioritized as well.
- There are a lot of food deserts in certain areas of the County where development of
 affordable housing is needed. Affordable housing development needs to take into
 consideration livability and quality of life and not just housing costs. Gladstone is one of
 these locations.

- There are very few subdivisions in the County or "traditional" neighborhoods such as in Lovingston. Nelson County needs to decide whether they want to allow dense subdivisions.
- Physiography of the County, due to its mountainous nature and soil types, hinders major development in most parts of the County.
- People come to Nelson because it is rural but if we continue to develop it, it will no longer be rural.
- There is a need for both improved education and tighter Zoning Ordinance regulations for short-term rental / residential development.
- Nellysford is a logical location for reasonable development.
- Family farms are quickly disappearing. Consideration should be given to raising the minimum agricultural lot size as a preservation tool.

On July 20, 2022, the Berkley Group facilitated a stakeholder listening session on hospitality, lodging, and tourism. This meeting was held at the Rockfish Valley Elementary School in a roundtable discussion format. Nine stakeholder attendees were present, representing organizations and businesses, such as Wintergreen Resort, Devils Backbone Brewery, Lockn' LLC, and Lovingston Get-Away AirBNB. Stakeholders were asked what issues and challenges their organizations and businesses see in the County. The following is a summary of the subsequent discussion.

Tourism

- Tourism for Nelson County is concentrated over short time periods such as being very busy in winter and summer but slow in fall and spring, or busy on the weekends but slow during the week. Encouraging year-round tourism is important for the local economy.
- The County could do a better job of connecting the major tourist areas with more of the
 natural environment that brings people to the area. There are no outfitters or services to
 get people from Rockfish up to the mountains or onto the rivers.
- There is a wide and diverse mix of tourists that come to the area of all age groups and types. Beyond Virginia and North Carolina, tourists are also coming from Washington D.C., Baltimore, Philadelphia, etc.

Lodging

- A lot of tourists that come to the County don't end up staying in the County. They will
 come for just the day and go back home or end up staying in one of the surrounding
 major cities. This is mainly because there are not enough places to stay in the County,
 especially traditional lodging venues such as major hotels.
- There is not enough diversity in lodging, with most of the lodging being made up of shortterm rentals. The average annual occupancy rate for short-term rentals in the County is 65%.
- The lack of sufficient infrastructure is restricting development of any major hotels. A couple have been proposed over the years but fell through.
- Lodging needs to be located along the Route 151 corridor and Nellysford for the busy tourist seasons. Lodging could also be beneficial along the Route 29 corridor during the non-tourist seasons.

<u>Transportation</u>

- Public transportation in the area should be improved for tourists. There are currently only private public transportation options in the areas frequented by tourists, such as Route 151, and many of them only operate during certain hours of the day.
- One idea would be a park and ride service located on Route 151 so that tourists could drive to the parking area and then get on buses that run the length of the corridor.

Events

- There is difficulty in finding first responder help for major events.
- Noise from events does not seem to be a big issue in the County. Traffic is seen as a larger problem than the noise generated.
- Nelson County is a premier wedding destination on the East Coast.

Miscellaneous

- There is a significant lack of housing for workers in the County. Because of this, there has been a lot of difficulty in finding adequate staff.
- Much of the worker housing in the area has been converted to short-term rentals because it is more profitable. One idea is a government program that would incentivize potential short-term rental property owners to operate their property as long-term rentals with monetary restitutions.
- Nelson County does not have any wayfinding signage and does not allow businesses to
 post directional signs or off-site signs. These are needed to help tourists navigate through
 the County.
- The emergency responder response times for the east side of the County is very slow.

On August 3, 2022, the Berkley Group facilitated a stakeholder listening session on agriculture and agritourism. This meeting was held at the Nelson Heritage Center in a roundtable discussion format. The 10 stakeholder attendees represented organizations and businesses, such as farm owners and operators, Blue Mountain Brewery, Mountain Cove Vineyards, Silver Creek Orchard, and Saunders' Brothers Farm Market. Stakeholders were asked what issues and challenges their organizations and businesses see in the County. The following is a summary of the subsequent discussion.

<u>Agriculture</u>

- Rural character, natural beauty, and agricultural lands are defining characteristics that are highly valued and important to preserve.
- Food and fiber will be the biggest issues Americans face.
- Stakeholders value the County's thriving farm markets that are very cooperative.
- Small farms are important. They support the small businesses that provide goods and services for farmers, like tractor repair shops. When small farms go out of business, we lose a lot more than just the farms.
- We need to make opportunities for younger generations to get into farming. This
 includes Career and Technical Education (CTE) for students as well as young adults. We
 need to keep young people here to have a strong agricultural economy. It was noted
 that the Farm Bureau offers young farmers expo and has a women's committee.
- There was strong support for "new farmer" programs that expand education programs to retirees and second-career professionals that have relocated to Nelson and want to transition into farming. This could include community college trainings, extension programs, and new farmer expos.
- The Farm Bureau offers a farmland transition program (Farm Link) that can be promoted.
 They connect retiring farmers with new, aspiring, and expanding operators.
- Land use taxation was viewed as vital to preserving agricultural land. The County should
 consider reducing the acreage for land use taxation. It is now 5 acres or more. However,
 smaller plots can make viable farms and sell at markets. If they can prove they have a
 viable agricultural business, some felt there should not be a minimum acreage. It was
 recommended that the County consider hybrid model based on acreage or business
 income.
- There are many restrictions on farmers that can be difficult. The County may not be able
 to change state or federal requirements, but they could help farmers navigate the
 federal rules so they can sell their products directly to the consumer.
- A farmer needs to "do a dozen things" to stay in business. The County should be supportive of all of the activities that can help sustain farming. One stakeholder shared the difficulty of obtaining a campground permit on his farm. The group agreed that processes should be easier for agritourism, farmers selling their products directly to

- consumers, etc. Do not put up any roadblocks for agriculture businesses that help them stay viable.
- We need to maintain support businesses for agriculture one farmer noted the long travel distances for feed and fertilizer.
- We need to strike a balance between landowners' rights, land use, and keeping farmland and agricultural lands. For some farmers, the value of their land is their retirement savings.

Land Conservation

- The County has easements and AFDs (agricultural forestall districts), each with its own unique benefits and impacts. It was noted that easements do not impact the composite index, which is a benefit. More education is needed on these programs.
- The County could consider transfer or purchase of development rights programs to encourage conservation and target development in appropriate areas.

Natural Resources/Environment

- Nelson has a "nature vibe".
- Integrity of waterways and biodiversity are important to the community.
- Dark skies draws tourism; there should be a strategy to educate the community about ways to maintain dark skies. The County has a webpage dedicated to dark skies.
- "Rockfish River is in trouble." Water quality and protection of pristine waterways should be a priority.
- Offer incentives to help property owners pay to plant riparian buffers and build fences
 to keep cattle out of the creeks. There is money available for plants, trees, fences,
 watering for cattle related to the Chesapeake Bay Watershed program.
- The focus is often on agriculture as the source of water pollution, but golf courses, lawns, and pet waste are also contributors.
- Ridgeline protection Wintergreen has covenants about preserving trees on the ridgeline. The County should do something similar.
- Nelson is a high-quality biodiversity area. There is an online map resource by the American Farmland Trust.

Economic Development/Tourism

- People want jobs with good pay so that residents can afford to live in the County, but they do not want manufacturing or industrial development that erodes the natural beauty.
- Fiber internet can help farming and change the dynamics of businesses that we can attract.

Housing

- It should be easy for farmers to allow their employees to live on the farm. It helps maintain the workforce to have housing available onsite.
- The cost of housing makes it nearly impossible to find employees for health care and education industries.
- Many people who work in Nelson live outside of the County. Brewery representatives indicated most of their workers live in Staunton, Waynesboro, and Charlottesville.

Development/Housing

- People have seen other counties "overdevelop" and want to prevent that here.
- Large lot subdivisions ruin the land.
- It is difficult to preserve rural land when the cost is so high.
- Large scale solar utilities consume land.
- Cluster housing and lot size regulations should be considered to preserve large plots of land. Cluster developments are preferable as opposed to large lot subdivisions.
- There is a lot of concern about there being so many short-term rentals for vacationers, but no long-term rentals for residents. It was noted that a Virginia Tourism report was recently released about short-term rentals.
- There is a need for responsible growth to provide parks and affordable housing, while also preserving farming. Balance small farms, affordable housing, and cluster development.

Transportation

- Truck traffic is an issue, and trucks should be slowed down.
- There was consensus that Route 151 should not become a 4-lane road. Big roads ruin the rural character; the roads should remain rural. Fewer lanes will also keep people driving slower and more safely.

Miscellaneous

• The people of Nelson County are open to new ideas. As an example, the Wildnerness Campaign was strongly supported. There is a healthy conservatism balanced with openness to new ideas.

On August 3, 2022, the Berkley Group facilitated a stakeholder listening session with community organizations. This meeting was held at the Nelson Heritage Center in a roundtable discussion format. The 10 stakeholder attendees represented organizations such as, Nelson Heritage Center, Rockfish Valley Community Center, Blue Ridge Medical Center, Nelson County Public Schools, Nelson Center, Nelson Community Development Foundation, Fleetwood Community Center, and Here to Stay. Stakeholders were asked what issues and challenges their organizations see in the County. The following is a summary of the subsequent discussion.

Community Centers

- The County has a history of decentralized community centers that serve localized populations. The plan should recognize the value of the existing centers. Keeping them decentralized helps provide access for everyone throughout the County.
- The community centers are owned by the County, but the County does not provide any money for maintenance. They are a great opportunity for investment by the County.
- The County should help form an association or consortium of all the community centers.
 The community center representatives felt there was an opportunity to share resources (such as staff) to provide valuable services to the whole community.
- Community centers are not getting the appropriate recognition and support from the Board of Supervisors.
- The County should prioritize investment in existing community centers and revitalize/enhance them instead of building a new centralized center.
- County resources can be used to leverage private funds. Perry Foundation grants was listed as an example.
- Public/private partnerships would help expand facilities and programs. For example, the community centers can host AAU, volleyball, and other tournaments to help pay for facilities.
- Invest in more grassroots organizations and centers to help fill the service gaps not fulfilled by the County.

Workforce

- The public school system is working on a partnership with the community college to help promote workforce development.
- Public school programs should train the workforce that Nelson County needs. This could include shadowing programs that prepare kids for life and success.
 The healthcare workforce is insufficient. It is difficult to find qualified employees, and
- Make connections between the public schools, community colleges and employers.

they cannot find housing in the County.

Recreation

- Playgrounds are lacking, and there are no County parks. The community centers provide some recreation. The County can provide more by partnering with public and private entities.
- Kids need opportunities to create community just as adults do. There is a need for more programs and places to congregate.
- A swimming pool is a dream. While expensive, one of the schools would be a logical location and could be used for education and competitive sports.
- Nelson has very high child obesity rates, which may be tied to the lack of recreation opportunity.

Housing

- Affordable, accessible housing is a challenge. Even school administrators and medical professionals have experienced housing challenges with the current shortage.
- There is no nursing home or assisted living facility.

Transportation

- The medical center is trying to give patients a ride. Many people cannot drive, and there are no public transportation options.
- Expand JAUNT to help provide transportation access to more community members.
- Aging population has difficulties getting around in the community. Adding some public transportation on Route 151 to connect to the BRITE system would allow them to get to Charlottesville for medical services.

Miscellaneous

- Stakeholders expressed strong, heartfelt love for the people of Nelson County that goes generations deep.
- Grassroots movements have made change happen in Nelson if something happens, it comes from the people, not top-down.
- Stakeholders appreciate the County's rural nature and natural beauty, along with rural amenities such as farmer's markets.
- The County's population is aging we need a more age-friendly and dementia-friendly community. Dementia Friendly Central Virginia (DFCV) is working to build awareness around this.
- We need to grow our own and create opportunities for children to come back here and have a job when they grow up. Culture and experience are what makes them want to be here. We need something for our kids to come back to or stay for.



Q1 What do you value most about Nelson County? (choose up to three):






Q5 Would you encourage or discourage the following land uses in Nelson County? (check one for each):






Q11 What recreation facilities do you want most in Nelson County? (choose up to three):






Q12 How would you rate the value of County services compared to the taxes you pay?




Q15 What general area of the County do you live in?:






Q16 Which best describes your current location of employment?


